#### **CALL TO ORDER**

The joint City of Granger/GSD Board Meeting was called to order at 6:00 PM by city Mayor Trevino. Mayor Trevino took roll call. Board President Paul Golob took roll call, followed by the flag salute.

#### **INTRODUCTIONS**

City Mayor asked his group to introduce themselves. Board President Paul Golob asked the district staff to introduce themselves.

## **GSD TOPICS OF DISCUSSION**

### A. SRO 19-20 school year

The city introduced their selected candidate for the SRO position. Robert Salinas was present and introduced himself to the board and city council. He gave a brief introduction and career history. Both City Council and GSD Board members had questions regarding his daily station/location and visibility. Office Salinas will be stationed primarily at the high school but will be present in each building, and at all sporting events at the high school. Officer Salinas will participate in the district crisis planning team as well as meeting regularly with each building principal. City council approved the joint contract between the city and the Granger School District. Granger School District board will meet on Monday June 24<sup>th</sup> to approve the SRO contract for the 2019-2020 school year.

## B. Grant Opportunities-for joint collaboration

The GSD Board continues to look for ways to collaborate on grant opportunities. At this time, the city does not have any new grant opportunities but will continue to look as well.

# C. 2<sup>nd</sup> Avenue pavement options

The city of Granger does not plan to pave  $2^{nd}$  Avenue at this time. As new development increases in the area, there may be a possibility of paving  $2^{nd}$  Avenue in the future.

## D. Future collaboration opportunities

The district communicated to the City Council know that we want to continue to collaborate with the City of Granger, and as opportunities arise, work together on joint projects.

## E. Chevron area property status

The city of Granger had no new information on the Chevron property status. The city has attempted to purchase land but the liens on the property were too large.

## F. Yakima Bait Company status

The city of Granger and GSD briefly discussed the status of the Yakima Bait Company. The city is aware that the Yakima Bait company laid off many employees, but has no other information regarding their future plans.

## G. Rezone 1 to zone 2 project and status

The GSD board wanted an update on the rezone project. Mayor Trevino let the board know that there will be a hearing on June 26<sup>th</sup> at 6pm. There was no new information at this point on the rezone.
